198. RENEWAL AND REGISTRATION OF CARDS OF CRICKET, ATHLETES, VOLLEYBALL & KABADDI FOR THE YEAR 2025-2026.

The Renewal and Registration of Cards of the Cricket, Athlete, Volleyball & Kabaddi for the year of 2025-26 through online will be commenced immediately. Participating Clubs are requested to collect Renewal Forms from the DSA Office during office hours.

199. DSA "A" DIVISION CRICKET LEAGUE 2025-26:

The above League for the year 2025-26 tentatively is focused to be started on 10th of November, 2025. Concerned clubs are advised to prepare their grounds accordingly.

200. D.S.A. 'B' DIVISION FOOTBALL LEAGUE 2025-26:

'B' Division Football League is in progress. Re-Fixation Fixture is published hereunder. Concerned clubs are requested to put up their teams accordingly.

201. DECISION OF THE DSA TRANSFER SUB-COMMITTEE:

ADDITIONAL DAYS ALLOWED TO PLAYERS WHO COULD NOT COMPLETE TRANSFER FORMALITIES DUE TO ENGAGEMENT IN REPRESENTING DSA OF ANY OF ITS MOTHER BODIES IN ANY TOURNAMENT.

Players on whose behalf prior intimation was received as regards their inability to sign the transfer documents during the period of winter transfer, i.e. 1st to 15th September, 2025 because of their absence from station due to participation in any tournament on behalf of DSA or any of his mother bodies, will be allowed to complete the formalities on any working day from 24th to 29th October, 2025 (excepting holidays). However, it is made clear that this facility will be allowed only to players selected to participate in any tournament on behalf DSA or any of its mother bodies and not to any one absent due to any other reason(s).

202. DECISION OF CRICKET SUB-COMMITTEE:

Final Selection Trial of U-18 & U-15 Boys of North 24 Parganas DSA Teams for CAB Inter District Tournament for 2025-26.

The above trial will be held at Jwapur Indoor Cricket Academy, Dum Dum on 18.10.2025 (Saturday) for U-18 Boys and on 19.10.25 (Sunday) for U-15 Boys. On 18.10.25 U-18 Boys – Morning Session from 10 A.M. (Reporting time 9 A.M.) for all selected players for Zonal Trials of Bongaon SDSA and BKP SDSA and all selected players from BKP Sub-Division who participated in CAB District Uniform Coaching Camp (2nd Phase from BKP Sub-Division). Afternoon session on 18.10.25, 1 P.M. (Reporting time 12 P.M.) for all selected players from Zonal Trials from Barasat SDSA and all selected players from zonal Trials from Basirhat SDSA. On 19.10.25 U-15 Boys morning session from 10 A.M. (Reporting time 9 A.M.) for all selected players from BKP Sub-Division and Bongaon SDSA and all selected players from BKP Sub-division who participated in CAB Uniform Coaching Camp (2nd phase from Barrackpore Sub-Division).
