177. TRANSFER OF PLAYERS FOR THE YEAR 2025-26:

The Winter Transfer of players (Athletic Sports, Cricket, Kabaddi and Volleyball) as per by laws 32(a)(ii) from one Club to another club and from one Sub-Divisional Sports Association/Zonal Sports Association to another Sub-Divisional Sports Association/Zonal Sports Association has been started from 1st September, 2025 and will continue up to 15th September, 2025 daily between 6-30 P.M. and 8-30 P.M. (excluding Sundays and Holidays declared by the Association). Players will have to come personally to the DSA Office along with Original & Xerox copy of Aadhaar Card & recent colour Passport size photograph and apply in the prescribed form with the requisite fees.

Registration of players for the Clubs directly affiliated to DSA will also be held as per the aforesaid schedule. Such clubs are required to get their players registered with DSA afresh as per by law 32 (e) within the dates mentioned herein before through online procedure introduced recently.

TRANSFER FORM is available from the DSA Office on any working days and cost of which Rs.10.00 (Rupees Ten) only. Transfer Fee Rs.60/- (Sixty) only. All Affiliated Units are requested to collect the same from 7-00 P.M. to 8-00 P.M.

183. ZONE WISE SELECTION TRIALS FOR U-15 & U-18 BOYS (CRICKET PLAYERS) :

Zonal preliminary Selection Trial of BKP Sub Division in relation to N. 24 DSA CAB Inter District Under 15 Boys Team 25-26 and Under 18 Boys Team 25-26 will be held on 13.09.25 & 14.09.25 at Yooger Pratic Ground, Shyamnagar. Trial will start from 10 A.M. onwards (Reporting time 9 A.M.) on both days. Under 15 Boys Trial on 13.09.25 (Saturday). Uner 18 Boys Trial on 14.09.25 (Sunday). All North 24 Pgs. DSA Affiliated Cricket Clubs may recommend the names of best 5 players (maximum) in each age group for taking part in the said trials mentioning the names of players. Their DOB and MOB No. in club letter head with sign and seal of signatories. Digital Birth Certificate of player is mandatory to appear in the Trial.

Cut Off date of birth of players. Under-15 boys must be born between 01.09.2010 and 31.08.2012, Under-18 boys must be born between 01.09.2007 and 31.08.2012. Players must be resident of Barrackpore Sub-Division. Players residing in other Sub-Divisions (except BKP. Sub Division) need not to appear in the Trials. Players have to carry the followings.

- 1) Original digital Birth Certificate and one photocopy, 2) Original Aadhaar card and its photocopy,
- 3) Two copies recent passport size color photos, 4) Club letter from DSA affiliated cricket playing club units.

5+5 players mean including those players who are selected for District Uniform coaching programme 25-26. Please mention "Uniform Camp" against such player of your club if they are selected for the Uniform Coaching Camp. They need not to appear at the preliminary trial as they have been selected by CAB coach. At final selection trials they will have to appear for final selection of our CAB Inter District Trial 25-26.
